## 1. Target market for this product

### **Target Market**

The retail clients for whom this product has been designed are investors who:

- want regular income and moderate capital growth;
- want a low-medium risk investment;
- want an investment with a time horizon of at least three (3) years;
- can make an initial investment of at least the minimum investment amount (generally \$50,000);
- want the ability to make additional contributions to their investment (including through regular periodic contributions);
- want half yearly income distributions; and
- want access to a selection of investment managers that specialise in managing specific asset classes.

### Product Description

The BCWF is a managed fund scheme for retail clients seeking a low-medium risk investment, who are looking for regular income and moderate capital growth via a selection of investment managers that specialise in managing specific asset classes with at least a 3 year time horizon.

### Product key attributes

Retail clients eligible for this product are Australian residents and retail clients who are non-residents residing in Australia.
