1. Target market for this product

Target Market

The retail clients for whom this product has been designed are investors who:

- want an income focussed portfolio with low capital volatility;
- want a low risk investment;
- want an investment with a time horizon of at least two (2) years;
- want the ability to make additional contributions to their investment (including through regular periodic contributions);
- want half yearly income distributions; and
- want access to a selection of investment managers that specialise in managing specific asset classes.

Product Description

The BDWF is a managed fund scheme for retail clients seeking a low risk investment who are looking for an income focussed portfolio with low capital volatility via a selection of investment managers that specialise in managing specific asset classes with at least a 2 year time horizon. This fund also allows investors to receive half-yearly income distributions.

Retail clients eligible for this product are Australian residents and retail clients who are non-residents residing in Australia.
