Important information about the Trustee of Bendigo SmartStart Pension

Account Number 16151342

On or about 1 May 2022 the Trustee and issuer of Bendigo SmartStart Pension is changing from Sandhurst Trustees Limited (Sandhurst) to Bendigo Superannuation Pty Ltd (Bendigo Super) ABN 23 644 620 128, AFSL534006.

Why is it changing?

Recent legislative conditions have been imposed on superannuation trustees, including Sandhurst. These conditions prevent Sandhurst from holding a duty to act in the interests of another person. As Sandhurst is Trustee for the Bendigo Superannuation Plan (BSP) as well as the responsible entity and issuer of a suite of managed funds, going forward these roles will be performed by different entities within the Bendigo and Adelaide Bank Group. This will see Sandhurst retire as Trustee of the BSP and the appointment of Bendigo Super as the new Trustee.

Who is Bendigo Super?

Bendigo Super is a newly established subsidiary company of Bendigo and Adelaide Bank Limited. It has been established with the sole purpose of being the Trustee of the BSP and looking after the interests of BSP and its members (you). Bendigo Super has been issued all relevant licences and authorisations by the regulators to operate as a Superannuation trustee.

Bendigo Super has established a new experienced board of directors while the senior management team that currently manages Sandhurst's superannuation business will remain in place. Sandhurst also remains as the investment manager of the underlying managed funds investment options of the BSP.

What does it mean for you?

There will be no change to the product or operation of your account and no action is required from you.

However, as a result of this change, the product disclosure statement (PDS), letters and forms will be updated to reflect the new trustee details.
